A	Professor/ Associate Professor (having minimum experience of 5 years as A.P. after Ph.D) in specialized areas of Science & Technology OR with equivalent designations and experience from Industries.	Rs.2500 per hour + Rs.800/- Transport allowance. Max ceiling Rs. 50000/- pm. for honorarium.
B	Professors (or equivalent) not covered in Group 'A' having Ph.D or M.Tech 3 years experience (in regular cadre) OR with equivalent designation & experience from industries.	Rs. 1500/- per hour + Plus Rs. 800/- Transport allowance. Max ceiling Rs 40000/- pm. for honorarium.
C.	Other persons not covered in (Group 'A' and 'B' having requisite qualifications of Assist. Professor)	Rs. 1000/- per hour , plus Rs. 500/- Transport allowance. Max ceiling. Rs 25000/- pm for honorarium.
